Course Objective

This unit addresses the skills and knowledge required to understand various types of data analytics technologies, tools and architecture. It also covers on statistical models, aligning data analytics to organisational needs and present relevant data for insights into HR strategies.

- Data analytics technologies and tools for HR management
 - Applications of advanced analytical methods in a human resource context
 - Types of data analytics
 - Principles of analytics architecture
 - Define the analytics architecture requirements
- Statistical models and methods
 - Methods of reviewing statistical models
 - Methods of preparing statistical models for operational use
 - Fine-tune the deployed models to ensure that it delivers the expected outcomes
 - Select the runtime environments for the statistical models to be deployed
 - Publish the statistical models to production
- Align and apply analytics applications to meet organisational needs
 - Existing analytical tools or data warehouse in the organisation
 - Define user requirements with the relevant stakeholders
 - Develop processes to support the operations of the model with relevant stakeholders
 - Implement analytical and visualisation techniques to present large quantities of data
 - Evaluate results to extract insights that may affect business HR strategies
